**RE: New York Hotel and Motel Trades Council, AFL-CIO Retainer
Agreement and Registration with the New York State Joint Commission
on Public Ethics and New York City Office of the City Clerk**

Dear Mr. Ward:

This letter is to confirm that Pitta Bishop Del Giorno & Giblin LLC ("Pitta Bishop") has been retained to represent New York Hotel and Motel Trades Council, AFL-CIO ("NYHTC") before all governmental agencies and bodies of New York State and the City of New York effective as of the date Pitta Bishop registers with the New York State Joint Commission on Public Ethics ("Commission") and the Office of the City Clerk of New York City ("City Clerk") and through December 31, 2016.

It is understood that because certain of the services performed by us on NYHTC's behalf, may be deemed to be lobbying services, periodic filings with the Commission and the City Clerk will be required of both Pitta Bishop and NYHTC. Once NYHTC is registered as a lobbyist client with New York State you will be required to file semi-annual reports with the Commission by July 15th of the current year and by the 15th day of January of the following year. In addition, once NYHTC registers as a lobbyist client with New York City, you will be required to submit a client annual report electronically to the City Clerk's office by January 15th of the following year. We will at the appropriate time send to you (a) letter(s) reminding you of these deadlines and we will, of course, assist you with these filings.

This confirms our understanding and agreement that no lobbying services will be performed by Pitta Bishop in behalf of NYHTC until the proper documentation has been filed with both the Commission and the City Clerk.

The rate of compensation shall be \$5,000 per month, plus reasonable disbursements. Payments of fees shall be due at the beginning of each service month. Disbursements shall be paid within thirty (30) days of the billing date. This agreement may be terminated by either party, with or without cause, upon thirty (30) days written notice to the other.



If we receive no comment concerning a bill within 30 days of receipt, the bill will be deemed accepted and approved by you.

Any unresolved disputes between us arising out of or under this agreement shall be resolved by final and binding arbitration before an arbitrator selected by our mutual agreement, and failing our agreement, pursuant to the rules of the American Arbitration Association.

If the above accurately reflects our understanding, please sign below and return the undersigned at your earliest convenience so that we may properly register with the Commission and the City Clerk on your behalf.
